DOT Kenya is part of the Canadian-led global network of DOT organizations (dotrust.org) that are leading economic and education change in countries throughout Africa, the Middle East, Asia and the Americas.

DOT Kenya is an innovator in enabling people to access and apply information and communications technologies (ICT) to create education, economic and entrepreneurial opportunities. DOT's vision is to make these opportunities available to marginalized people, especially women and youth, as a strategy to eradicate poverty, vulnerability and gender inequality. DOT's signature entrepreneurship program, ReachUp!, integrates ICT, life skills, and micro-enterprise development and is delivered in a cost-effective manner, using university graduates to train and build capacity of youth in their communities. DOT transforms and supports young women and men, as they become leaders of economic and education change in their societies.

DOT operates within a fundamental principle of local ownership. DOT invests in local management and staff, creates a local organization with a local board of directors and develops a local business plan to govern sustainable, growth, local resource expansion and local job creation.

DOT Kenya is a young, agile and rapidly growing organization with a proven track record and a network of national and community-based partners. DOT Kenya is currently supported by the Canadian International Development Agency and has recently received a major grant from The MasterCard Foundation to scale its programming in Kenya and Rwanda.

The Position

Reporting to the Canada-based Senior Director – Global Operations, the Kenya Country Director is the local executive responsible for leading the delivery and growth of DOT Kenya programming. The Country Director is

responsible for program operations, organizational development, in-country fund-raising, partnership and stakeholder relations, Board relations, and is the overall external spokesperson for the DOT program in Kenya. The Country Director is a member of the East Africa management team led by the Director of DOT's East Africa Regional Support Office.

The position is located in Nairobi, Kenya.

Responsibilities

- Manages all aspects of DOT Kenya operations;
- Manages, owns and implements the strategic plan and vision for DOT Kenya country operations and programming;
- Accountable to DOT global and local stakeholders for program
 effectiveness ensures programming is responsive to partner and
 beneficiary needs;
- Hires team members, sets individual performance expectations, manages human resource issues;
- Ensures that all staff have clearly defined roles and responsibilities and access to the resources they require to be successful;
- Ensures the accurate, cost-effective and transparent financial management of the operation;
- Ensures policies and procedures are implemented that support transparent, accountable, efficient and effective country operations;
- Owns the publicity/PR/promotion plan with potential donors and partners as key target audience;
- Maintains high-level communications and relations with a growing network of relevant stakeholders (community, government, private sector partners and donors);
- Leads development and implementation of local sustainability and growth plan with support of Director of the Regional Support Office;
- Ensures standardized and coordinated monitoring and evaluation of program outcomes and makes recommendations to rest of team, DOT global, and stakeholders;
- Collaborates with other DOT country directors, the Regional Support Office and the DOT global management and executive teams.
- Maintains timely and effective communication with the Board of Directors.
