## DIASPORA DEMAND FOR REPRESENTATION & REGISTRATION TO VOTE: A PRESS STATEMENT (22ND AUGUST 2011)

The Group of Forty-Seven (G-47) and the Diaspora Alliance were formed to contribute to the efforts towards *a just, free, prosperous, united and equitable Kenya*. We believe that Kenya is blessed with a citizenry (both at home and abroad) whose desires include rebuilding Kenya based on socio-economic justice, rule of law, peace and equity.

As a result, we, like all other citizens' groupings yearning for change in Kenya, were reasonably satisfied with the passing of the constitution, which provided for, among other things, registration to vote and representation in Parliament and other decision-making bodies, for the over 3 million Kenyans living outside the country. Indeed, this was a step long overdue, as Diaspora Kenyans constitute a large political and economic constituency, which until now has not been represented in any of the country's decision-making apparatus. This is even more disturbing when one realizes that the Diaspora community contributes over US\$ 1 billion (over Kshs 90 billion) annually in direct remittances to the economy of Kenya, making it no doubt the most important foreign exchange earner in the country. In fact in 2010, official World Bank and Central Bank of Kenya (CBK) reports indicate that the Diaspora remitted about US\$ 1.8 billion (or KShs 150 billion at last year's exchange rates) into the national economy.

It is therefore concerning to the Diaspora community at large that, even though the constitution makes it clear that it is our right to participate in decision-making processes and be represented just like all other Kenyans, there appear to be no plans in place to actualize this right. Indeed, we are particularly disturbed to learn that the two major political parties in the governing coalition are actively engaged with each other in attempting to block or adversely delay the enactment of the relevant laws and statutes that would actualize Diaspora registration and representation.

Concerned at what appears to be deliberate exclusion of Diaspora in matters of strategic, national importance, last year some of our members went to court to demand registration of Diaspora to participate in the land-mark referendum vote. While acknowledging that the time left at the time for the vote was not enough to register the Diaspora, the Court directed appropriate arms of government, especially the Interim Independent Electoral Commission (IIEC) to ensure that Kenyans outside the country vote in ALL future referenda and national elections.

The G-47, the Diaspora Alliance and their various member organizations will not accept this denial of our right to vote and be represented. The Diaspora community has as important a stake in the country as all other citizens, and has the right to be heard at all decision-making levels in all arms of the State and government.

We urge the two parties in the Governing Coalition, as well as all Kenyans of goodwill, to facilitate actualization of the right of Kenyans abroad to be represented and to vote for their leaders. Indeed, going by the constitutional provisions recognizing equality of the vote, we expect that in delimiting the 80 new constituencies, that five (5) shall be reserved for Diaspora candidates, each per continent as you find Kenyans literally in every corner of the globe. This way alone can the large constituency of voters living outside the country be represented and feel connected with our Kenyan brothers and sisters at home.

With today's available online and electronic voting (e-voting) and e-participation technologies, it is no longer impractical for Diaspora to participate in elections, and also to have Diaspora legislators as already happening in Sierra Leone, South Africa, Iraq, Cameroun, India, and Philippines, among others.

We believe that it is not late to make the required changes to the political set-up in Kenya in order to actualize the rights of Diaspora Kenyans to be represented, and to select their leaders freely in accordance with the constitution of the Republic.

It upholds the supremacy and right of every Kenyan (including the Diaspora) to vote and participate in all matters of national importance, including policy, legislation, governance and leadership. The Diaspora Alliance (whose member organizations are listed below) continue to seek to integrate and mainstream the Diaspora in the national psyche and economy, and champion their rights and interests, alongside the wider national common good.
