Thank you for your continued partnership and support, including during but not limited to the 'Katiba Bash' in October last year. We are pleased to inform you that since, both New Vision Kenya (NVK) and its Investment Club, NVIC, have grown tremendously. Within 6 months of launch, NVIC has already secured, indeed surpassed the 50 shareholders targeted at time of the launch. In addition, the Club has already rolled out four programs, including:-

- i) Launched branded Taxi-Fleet, *Dial-a-Cab*, with one Vehicle already on the road in Juba, and the second due to be deployed before end of the month (and also discussions on Franchises advanced);

- iv) 60-Unit Housing Project in Nairobi (in partnership with Everest Properties & Shelter Afrique). A Partnership Agreement is well under-way.

Recently, we joined other Kenyans in Nairobi through the *Kenyans4Kenya* Initiative to make our modest contribution of *KSh* 30,000 to the famine and hunger-ravaged Kenyans in the Northern Districts, aired widely in the local media. To move a notch higher, we are intent on expanding the membership and horizon of the Club. Accordingly, an *End-Year 'Mbuzi Choma' Get-Together Party* is planned for *Saturday*, *10th December*, *2011 from 6pm at Nile Beach Hotel*, *Juba*. We shall use the opportunity to enlighten more Kenyans on NVK and its programs, and also review the year's performance. We wish to extend a *Special Invitation* to you and two other senior Embassy staff to this event.
